Atchison Topeka & Santa Fe Railroad (AF&SF) copy of G.M. Dodge's map of the Texas & Pacific Railroad lines, which has been redlined by the AT&SF engineers to show the proposed line connecting the Atlantic & Pacific Railroad with the Texas & Pacific Railroad in 1938, with accompanying transmittal letter.

The map shows the Texas & Pacific Railroad's lines between Texas, Indian Territory and San Diego. among the more unique details are the finished and proposed lines of the T&P and the various land reservations granted to the T&P by the Federal Government in Indian Territory, Texas, New Mexico, Arizona and California.

The map includes a redline identifying what was previously the the line of the Atlantic & Pacific Railway extending to Sweetwater. At the time, the T&P and AT&SF were contemplating completing this line in 1938, as discussed in the accompanying letter: {{ inventory enlarge link('31206a') }}

Gentlemen-

Through the kindness of Mr. E F Mitchell, Chief Engineer of the T&P, Dalls, he furnished me a photo copy of the T&P map of surveys and completed road, 1873, G M. Dodge, Chief Engineer, print of which is attached.

I wish to call your particular attention to te proposed connection of the A&P with the T&P in the vicinity of Sweetwater (Western Texas). Of course, the A&P was not constructed in that direction but instead eventually went via Albuquerque.

It may interest you to know that the T&P actually built 10 miles out of San Diego northward. The construction of the T&P was stopped at Sierra Blanca at bou the same time when construction of the T&P was stopped at the Needles, and on account of the activies of thesame parties, namely Jay Gould and Collis P. Huntington.
